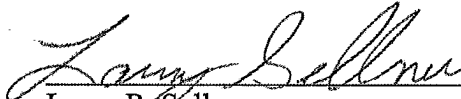

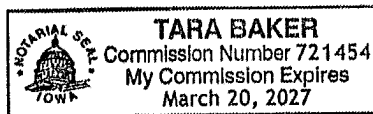
STATE OF IOWA, COUNTY OF DELAWARE, ss:

1. Irvin Sellner a/k/a Irvin L. Sellner died on January 3, 2019 survived by his wife, Madonna Sellner a/k/a Madonna A. Sellner. Madonna Sellner died January 21, 2026.
2. I am the son of Irvin Sellner and Madonna Sellner and I have personal knowledge about the information contained herein.
3. Title to all of the real estate described in Exhibit A was established in Irvin L. Sellner and Madonna A. Sellner, husband and wife, as joint tenants with full rights of survivorship, and not as tenants in common by Warranty Deed – Joint Tenancy dated November 2, 2015 and filed November 13, 2015 in Book 2015, Page 3103 of the records of Delaware County, Iowa.
4. After the deed referenced in paragraph 3 above was recorded, the legal description of the real estate changed by subsequent plats and deeds.
5. I hereby request that the auditor enter this information on the transfer books pursuant to Section 558.66 of the Iowa Code to show that all real estate owned by Irvin L. Sellner and Madonna A. Sellner is now owned by Madonna A. Sellner.
6. Form 706, United States Estate Tax return, is not required to be filed as a result of the death of the Decedent.
7. An Iowa inheritance tax return is not required to be filed pursuant to Iowa Code Section 450.22 subsection 3.

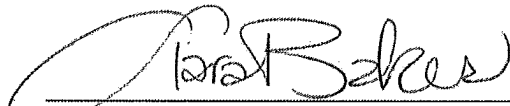
