 Grases his heirs and assigns the following lots called
 Land situated in the State of Ohio to wit: The east
 half of the northeast quarter of section No eleven (11) and the
 North half of the northeast quarter of section No fourteen (14) in
 Township No twenty five (25) North of Range No Twenty four
 (24) west of the 1st principal meridian being the land located
 by United States Military Land warrant No Sixty three and
 four hundred and twenty (60.420) at the United States Land
 office at Fairfield. We are and to hold the said premises
 with all the furniture and appurtenances and appurtenances
 in anywise pertaining to the same And I the said Abrahm Buck-
 ingham for myself and my heirs executors and adju-
 dicators do covenant with the said Joel Grases his heirs &
 assigns that I do and will warranty defend the premises hereby
