 To have and to hold the said premises as above described unto the
 said party of the second part his heirs and assigns forever and the said
 party of the first for themselves and their heirs Executors and Adm-
 inistrators do hereby Covenant to and with the said party of the second
 part his heirs Executors Administrators and assigns that they are
 well Seized of the the Premises above Conveyed as of good and
 indefeasible estate of inheritance in fee Simple and have good
 right to Sell and Convey the same in manner and form aforesaid
 That the above described premises are free from all incumbr-
 ances and that the above described in the quiet and Peaceable
 possession of the said party of the second part his heirs or assigns aga-
