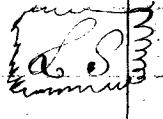

do or cause to be done by virtue thereof.

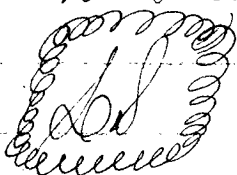
