 Located the northwest quarter of Southeast quarter of section 16 in Township 14 North Range 20 East of the fifth Principal Meridian in Madison County Iowa. Same is laid out in a square being one thousand and sixty two feet on each side the streets and alleys running north and south and east and west crossing each other at right angle and dividing the plat into thirty six blocks being one hundred and twenty feet square and containing two lots each. The blocks numbered from the block east corner to the south and the lots numbered from the block east corner to the west as exhibited on the plat. The names of the streets and alleys are as follows to wit Brown street being on the north side sixty feet wide South of Brown street Hamilton street seventy eight feet wide South of Hamilton street Applegate street seventy eight feet wide on the south side of Applegate street the streets of leading north and south are named as follows to wit Biemke street on the west side fifty feet wide Biemke street seventy eight feet wide East of Biemke street Anthony street seventy eight feet wide East of Anthony street Main street seventy eight feet wide

Washington street on the East side sixty feet wide
the other sixteen feet wide running parallel with the street
and at equal distance from them. Rock planted in the
corner of each street as a dividing line.
