 and state above named the receipt whereof is hereby acknowledged as here
 by bargain sell and convey to the said John M Mycoff and to his heirs and as
 signs forever the following real estate in Madison County and state of Iowa
 and describe as follows to wit the undivided half of the south west of the
 north East quarter; South East quarter of the north West quarter; north west
 quarter of south East quarter and north East quarter of south west quarter
 of section no One (1) in Township number seventy six South of Range no
 Twenty nine Containing Eighty acres be the same more or less together
 with all the privileges and appurtenances to the same belonging to have and to
 hold the same to the said John M Mycoff and to his heirs and assigns
 forever the grantors their heirs and assigns hereby Covenanting with the
 grantees his heirs and assigns that the title so conveyed is clear free and unincum
 bured that they are lawfully seized of the premises aforesaid as of a sure
 perfect and inalienable estate of inheritance in fee simple and that they will
 warrant and defend the same against all claims Whomsoever in witness
 whereof the said John H Harris and Jane Harris his wife have hereunto
 set their hands and seals this twenty fourth day of October 1854
