 part for and in consideration of the sum of one thousand dollars lawful
 money of the United States of America to them in hand paid by the said
 party of the second part at or before the executing and delivery of these pres-
 ents to the receipt whereof is hereby acknowledged have granted sold alien-
 ced and released Conveyed and confirmed and by these presents do grant
 bargain sell alien release convey and confirm unto the said party
 of the second part and to his heirs and assigns forever all that certain
 lot place or parcel of land situate in the County of Madison State of Iowa
 and described as follows being the south half of south east quarter
 of Section No 35 T 47 Range 26 and being the same premises which
 were conveyed by Josiah Knott to Nels L Pratt and by Nels L Pratt
 were conveyed to the party of the first part together with all and singular
 the tenements hereditaments and appurtenances thereto belonging or in
 anywise appertaining and the reversion and reversions remainder and remainder
 rents issues and profits thereof and also all the estate right title interest above
 written of Owner property possession claim and demand whatsoever as well in law
 as in equity of the said parties of the first part by in or to the above described
 premises and every part and parcel thereof with the appurtenances to have and
 to hold all and singular the above mentioned and described premises together
 with the appurtenances unto the said party of the second part his heirs and
 assigns forever and the said William A Collins his heirs the said premises in
 the quiet and peaceable possession of the said party of the second part his heirs
 & assigns against the lawful said party of the first part their heirs and assigns
 all and every person and persons whomsoever lawfully claiming or to claim the
 same shall and will warrant and by these presents forever defend witness
 whereof the said parties of first part have hereunto set their hands
 and seals this the day and year first above written
