 parties of the first part, for and in consideration
 of the sum of three hundred dollars to them in
 hand paid by the said party of the second part, the
 receipt whereof of which is hereby acknowledged,
 have granted and sold, and by these presents do
 grant, bargain and sell and convey and confirm, unto
 unto the said party of the second part, his heirs and
 assigns forever, the certain tract, or parcel of real
 estate, situated in the County of Madison,
 State of Penn to wit; The South East quarter of
 section Number six in Township Number Seventy
 Seven North, of range number Twenty Nine West of the
 fifth principal Meridian, containing one hundred
 and sixty acres.

To have and to hold the premises above described,
 with all the apertures thereto belonging, unto him
 the said second party and to his heirs and assigns for-
 ever, The said Isaac Hale and Abigail his wife
 hereby covenanting for themselves, their heirs, executors
 and assigns administrators, that the above described prem-
 isses are free from any incumbrance; that they have
 full right, power and authority to sell the same,
 and they will warrant and defend the title unto the
 party of the second part, his heirs and assigns against
 the claims of all persons whomsoever lawfully claiming
 the same. And the said Abigail the wife of the
 said Isaac Hale hereby releases and relinquishes all
 her right of Dower in and to the foregoing described
 premises.
