Sheriff's Deed. Whereas on the 22^d day of May AD 1858 James James
P. O. Deed of the County of Madison and State of Iowa filed his
James James Jr. Petition in the district court of the County of Madison
and State of Iowa against Lewis R. Jones, asking the sale
of a mortgage on the following real estate to wit the South half(s) of the South East
quarter(1/4) of the South West quarter(1/4) and South East 1/4 of the South West
quarter of section two(2) Township seventy-five 1/2 Range twenty seven 27
in Madison County, and State of Iowa and whereas at the March term of said
District Court said proceeding were had upon said Petition that a decree of
foreclosure was entered by said Court upon said Mortgage for the sum of three
hundred and thirty five dollars being principal interest and costs of suit
and whereas on the 29th day of April AD 1858 a special execution was issued
by the Clerk of said Court directed to the Sheriff of said County Commanding
him to make the amount of said judgment out of said real estate
described as aforesaid to be sold at Public outcry, and the said Sheriff
after having caused said land to be duly advertised for more than four
weeks did on the 22^d day of May AD 1858 sell said real Estate to James
James Jr. for One hundred and fifty Dollars the being the highest
and best bidder all of which will more fully appear reference be had
to the proceedings had in said cause wherefore I, Joseph
R. Evans Sheriff as aforesaid in consideration of the premises and
by virtue of the power in me vested by law do by these presents
Grant, bargain and convey unto the said James James Jr.
and unto his heirs and assigns forever said real estate so sold

him the said James James Jr. for his heirs and assigns forever
