 of the second part forever release and discharged herefrom have granted
 bargained sold conveyed remise released aliened and confirmed by
 these presents do grant bargain sell remise alien and confirm unto the said
 party of the second part and to his heirs and assigns forever all of the following
 described premises situate lying and being in the County of Madison & State
 of Iowa to wit the North half ($\frac{1}{2}$) of the South East quarter ($\frac{1}{4}$) of Section twenty
 three (23) in Township seventy seven (77) North of range twenty eight (28) West
 containing Eighty acres (80) according to the certificate No 51269 issued to
 George D Nicholson March 1st 1835 by T A Walker Register Together with
 all and singular the hereditaments & appurtenances thereto belonging or in
 anywise appertaining & the reversions & reversions remainders & remainders rents issues
 & profits thereof & all the estate right title interest claim or demand whatsoever of
 the said party of the first part either in law or Equity of in and to the above barga-
 ined premises with the hereditaments & appurtenances to have and to hold the said
 premises above bargained and described with the appurtenances unto the said
 party of the second part his and their heirs and assigns forever and the said
 party of the first part for their heirs executors & administrators do covenant
 bargain & agree to & with the said party of the second part his heirs and assigns
 that at the time of the executing and delivery of these presents the said S B Spau-
 lding and his wife Roana R Spaulding are well seized of the premises above
 conveyed as of a good sure perfect absolute and indefeasible state of inherit-
 ance in the law in fee simple and have good right full power and lawful
 authority to grant bargain sell and convey the same in manner and form aforesaid
 and that the same are free and clear of all former and other grants bargains
 sales leases judgments taxes assessments and encumbrances of what kind and nature
 soever and the above bargained premises in the quiet and peaceful possession of
 the said party of the second part his heirs and assigns against all and every
 person or persons lawfully claiming or to claim the whole or any part thereof
 shall and will warrant & forever defend ~~as~~ witness whereof the said party
 of the first part herein to set their hands & seals the day and year first
 above written.
