Stephen Abrams

Know all men by these presents that whereas Stephen Abrams on the 11th day of March AD 1859 filed his petition

in the District Court of Madison County Iowa asking the foreclosure of a certain Mortgage therein set forth and described which said Mortgage was given on the West half (1/2) of the South West quarter of Section Number Eleven (11) and the East half (1/2) of the South East quarter of Section Number ten (10) all in Township No Seventy Six "76" North of Range Number Seventy Eight "28" and in Madison County Iowa, and whereas the said Mortgage was executed by Daniel Vanway Sarah Ann Vanway to the said Stephen Abrams and whereas the said Daniel Vanway Sarah Ann Vanway have duly and legally notified of the filing of said petition and whereas such proceedings were had in the premises by the District Court of Madison County Iowa that the said Stephen Abrams on the Twelfth day of April AD, 1859 obtained a decree of foreclosure of the equity of redemption in and to the said land above described and whereas a special execution was on the fourth day of May AD, 1859, issued from the Office of the Clerk of District Court in and for said County under the seal of said District Court directed to the Sheriff of said County commanding him to sell the said land above described and whereas the said Sheriff after having given the notice in accordance with the law in such cases made and provided on the second day of July AD, 1859 proceeded to sell the said land above described at public outcry and whereas the said Stephen Abrams bidding five hundred dollars for said land and whereas the said Stephen Abrams being the highest and best bidder for said Sheriff in consideration of the premises aforesaid deed in consideration of the said sum of five hundred dollars, I Joseph H. Evans as the Sheriff of said Madison County Iowa, hereby sell and convey unto the said Stephen Abrams the said land to wit, the West half (1/2) of the South West quarter (1/4) of Section Number Eleven (11) and the East half (1/2) of the South East quarter (1/4) of Section Number ten (10) all in Township number Seventy Six "76" North of Range Number Seventy Eight (28) in the County of Madison and the State of Iowa, and I as the said Sheriff of Madison County Iowa warrant the title to the said land against the lawful claims of all persons whatsoever.
