 of Iowa on the 21st day of June A.D. 1856 made and executed
 and delivered to Edward Wood then of the same County,
 and State a Mortgage in fee simple upon the Real Estate

 the payment of the sum of eighteen hundred and seventy
 dollars with ten percent interest thereon from date
 according to the tenor and effect of four certain
 promissory notes of even date with said Mortgage

 still remains unpaid and whereas the said Mortgage
 was not signed or acknowledged by me at the time
 of the execution thereof by the said John W. Thompson

 sideration of the premises and of the sum of one dollar
 to me in hand paid by the said Edward Wood I
 Isabella J. Thompson wife of the said John W. Thompson
