and convey unto William S. Smith of the same City County
and State aforesaid, the following described premises situated
in the County of Madison and town of Winterset in the State
of Iowa being a part of a certain four (4) acre lot or tract of
land lying in a square form in the South East corner of the
West half (1/2) of the South East quarter (1/4) of section Number
thirty six (36) in Township Number Sixty six (66) North of
Range Number Twenty Eight (28) West of the 5th P.M. and bounded
particularly described as follows to wit commencing at a
point in the West line of the said four (4) acre lot, twelve (12)
rods North of the South West corner of the same and
running thence East parallel with the South line of said four
(4) acre lot eight (8) rods. Thence North parallel with said
West line for and Twenty eight one hundredths ($28\frac{1}{100}$) Rods,
thence West parallel with said South line Eight (8) rods
to the said West line. Thence South along said West line
five and twenty eight one hundredths ($28\frac{1}{100}$) rods to the
place of beginning. Above North West quarter of the North
West quarter of section No. three (3) Township No. Seventy
four (74) Range No. twenty eight (28) West of the 5th P.M. Iowa
Containing forty (40) acres more or less.
