I, John G. Vauter and Elizabeth Vauter  
 his wife, of Madison County, State of

Iowa in consideration of the sum of Two Thousand Dollars  
 in hand paid do hereby sell and convey unto Albert West  
 of Madison County and State of Iowa, the following  
 described premises, to wit, the West half of the South West quarter ("4")  
 except so much thereof as is hereinafter described and the South  
 East quarter of the South West quarter of section number  
 Twenty four "24" and the South East <sup>quarter</sup> of the North West quarter  
 of section number fourteen "14" in Township No. Seventy  
 Five "75" North of Range number twenty One "26" West of  
 3<sup>rd</sup> P.M. and also the undivided two thirds of so much of the  
 said West half of the South West quarter and of the West half of the  
 North West quarter of said section No. Twenty four "24" as is con-  
 tained in the following bounds, to wit, commencing at the South  
 east corner of the said West half of the North West quarter, and  
 running thence north eight "8" rods thence West seventeen "17  $\frac{1}{8}$ "  
 and Seven Eighths  $7 \frac{7}{8}$  rods, thence South eighteen "18" rods, thence  
 South East seventeen and Seven Eights "17  $\frac{7}{8}$ " rods, thence North  
 ten "10" rods to the place of the beginning together with the  
 Steam Saw Mill, Steam Engine, and all and singular the  
 fixtures and appurtenances belonging thereto, situated in the said  
 last mentioned tract of land and also all other the tenements and

And we do hereby covenant with said Albert West that  
 we are lawfully seized of said premises, that they are free

and that the said Elizabeth Vauter hereby relinquishes  
all her right of dower in and to the above described premises
