deived of the premises above conveyed as of a good sure  
perfect absolute and indefeasible state of inheritance is  
the said wife simple and have good right full power and  
lawful authority to grant bargain sell and convey the  
same in manner and form aforesaid and that the same  
are free and clear of all former and other grants bargains  
sales leases judgments taxes assessments and incumbrances  
of what kind and nature soever and the above bargained  
premises is the quiet and peaceful possession of the said  
party of the second part his heirs and assigns against  
all and every person or persons lawfully claiming  
or to claim the whole or any part thereof shall and  
will covenant and forever defend arise whereas the  
party of the first part on the first day of November  
in the year of one thousand one thousand eight hundred  
and fifty nine desiring to deed the above described  
premises to Robert Jones the party of the second part  
did by mistake spell the name of the party the second  
part Robert Johns instead of Robert Jones and did  
deed the above described premises to Robert Jones  
and whereas said deed was filed for record on the  
sixteenth day of November one thousand eight hundred  
and fifty nine and duly recorded in Book L of
