Williams as the widow of said Elias Williams late of Madison County Iowa deceased from the Estate of the said Elias Williams deceased as aforesaid and for me and in my name good and sufficient receipts acquittances & discharges therefor to make & give and also for me and in my name to bargain sell grant convey and confirm all my dower third right title interest property claim and demand whatsoever in Law and Equity of me said Winifred Williams widow of said Elias Williams late of Madison Co. Iowa deceased as aforesaid of in and to the real estate belonging to the estate of the said Elias Williams deceased as aforesaid for such price or sum of money or on such terms as he may think best and for me and in my name to make execute acknowledge & deliver unto the purchaser or purchasers thereof good and sufficient deeds conveyances or other discharges to make and give and to demand receive and collect all sums of money which shall become due and payable to me by reason of such sale or sales giving and granting unto my said Attorney full power and authority to do and perform all and every acts and things whatsoever requisite and necessary to be done in and about the premises as fully and to all intents & purposes as I might or could do if personally present with full power of substitution & revocation hereby ratifying & confirming all that my said Attorney or his substitute shall lawfully do or cause to be done by virtue hereof In witness whereof I have hereunto set my ^{hand} and seal this 6th day of March one thousand eight hundred and Sixty one
