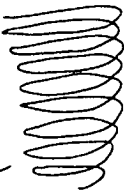

hundreds Dollars in hand paid do hereby sell and convey unto John
 Brunson of Madison County Iowa the following described real
 estate situated in the City of Winterset County of Madison and
 State of Iowa being a part of a certain four acre tract or lot
 of lands lying in a square form in the South East corner of the
 west half $\frac{1}{2}$ of the South East quarter $\frac{1}{4}$ of Section Number thirty
 Six 36 in Township Number Seventy Six 76 South of Range
 Number Twenty eight 28 West of 5th P.M. and more particularly
 described as follows to wit commencing at a point in the
 South line of said four acre lot Twelve 12 rods west of the
 South East corner of the same and running thence North
 parallel with the East line of said four acre lot Thirteen
 rods thence west parallel with said South line five and
 Twenty eight one hundredths $58 \frac{28}{100}$ rods thence South parallel
 with said East line thirteen 13 rods to the ^{said} South line
 thence East along said South line five and Twenty eight
 one hundredths $58 \frac{28}{100}$ rods to the place of beginning. And
 also commencing at a point in the East line of said four
 acre lot Nine and Twenty eight one hundredths $9 \frac{28}{100}$ rods
 North of the South East corner of the same and running
 thence north along said East line four 4 rods thence

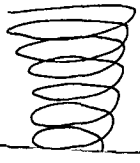
