a part of the west half of the North East Quarter of Section No  
thirtyone (31) in Township No Seventy-six (76) North of Range  
No Twenty-six (26) West. Commencing at the north west corner  
of said North East Quarter of Section No thirtyone. Running South  
with the Township line one hundred & Sixty rods thence East to  
Henry Whitcombs line thence west along said line North to the Section  
line thence West along said <sup>section</sup> line to the place of beginning containing  
Seventy five acres and forty nine hundredths more or less And the
