 hereby acknowledged have granted bargained and sold and by these Presents
 do grant bargain and sell unto the said party of the second part
 her Heirs and Assigns, all the following described lot, piece or parcel of
 Land situated in the Town of Winterset in the County of Madison and
 State of Iowa to wit: the north half ($\frac{1}{2}$) of lots three (3) and four (4) in
 Block No four (4) Guilemon's Addition to the Town of Winterset in the
 County of Madison & State of Iowa
 Together with all and Singular the Hereditaments and Appurtenances
 thereto belonging, or in any wise appertaining and the reversion and
 reversions, remainder and remainders rents, issues and profits thereof
 And all the Estate right title interest claim and demand whatsoever, of
 the said party of the first part, either in law or equity of in and to the above
 bargained premises with the hereditaments and appurtenances thereunto
 and to hold the said premises above bargained and described with
 the Appurtenances unto the said party of the second part his and
 Assigns forever. And the said Walter J. Lyons one of the parties of the first
 part, for his executors and Administrators does covenant grant
 bargain and agree to and with the said party of the second part
 her heirs and assigns that at the time of the sealing and delivery of
 these presents he is well seined of the premises above conveyed as of a
 good, sure perfect absolute and indefeasible estate of inheritance, in law
 in fee simple and has good right full power and lawful authority
 to grant bargain sell and convey the same in manner and form
 aforesaid and that the same are free and clear from all former
 and other grants, bargains, sales, leases, taxes, assessments and incum-
 brances of what kind or nature soever. And the above bargained
 premises in the quiet and peaceable possession of the said party of the
 second part his heirs and assigns against all and every person
 or persons lawfully claiming or to claim the whole or any part
