**Know all Men by these Presents, That I, Alexander Ballentine**

of Madison County and State of Iowa — in consideration of the sum of Two Hundred <sup>100</sup> Dollars, in hand paid, by W. W. M<sup>c</sup>Knight of Madison County, and State of Iowa do hereby **Sell and Convey**, unto the said W. W. M<sup>c</sup>Knight

the following described premises, situate in the County of Madison, and State of Iowa, to-wit:

The North East quarter of the North West quarter of Section Thirty six, Township Seventy seven, Range Twenty seven. This conveyance to be void on condition that the said Alex. Ballentine shall well and truly pay to said W. W. M<sup>c</sup>Knight two certain promissory Notes executed by said Ballentine to said M<sup>c</sup>Knight described as follows — One dated Jan. 9<sup>th</sup> 1861, and calling for payment one day after date of One Hundred and fifty one ~~100~~ Dollars with ten per cent Interest, on which Aug. 26. 1863 is credited a payment of interest in full, and on the 17<sup>th</sup> day of Oct. 1864 is credited the interest in full to that date. The other of said Notes dated Oct. 17. 1864 and calling for the payment of Seventeen dollars and ~~3~~.<sup>00</sup> with ten per cent interest, otherwise in full force.
