H. J. B. Cummings Know all Men by these presents; That whereas, the following described real property, viz; But Lot No Six (6) in South Addition of Out lots to the City of Winterset situated in the County of Madison, and State of Iowa, was subject to taxation for the year AD 1855 & 1859; and whereas the taxes, assessed upon said property, for the years aforesaid remained due and unpaid at the date of the sale hereinafter named; and whereas, the Treasurer of the said County did, on the 5th day of November 1860, by virtue of the authority in him vested by law, at Winterset the sale begun and publicly held on the first Monday of November AD 1860, expose to public sale at the Treasurers Office in the County aforesaid in substantial conformity with all the requisitions of the statute in such case made and provided, the real property above described, for the payment of the taxes, interest and costs then due and remaining unpaid on said property; and whereas, at the time and place aforesaid, H. J. B. Cummings of the County of Madison and State of Iowa, having offered to pay the sum of Five (5) dollars seventy five cents being the whole amount of taxes, interest and costs then due and remaining unpaid on said property, for But lot No Six (6) in South Addition of Out lots to the City of Winterset, which was the least quantity bid for: and payment of said sum having by him made to the said Treasurer, the said property was stricken off to him at that price, five & 75/100 dollars, and whereas three years has elapsed since the date of said Sale and the said property has not been redeemed therefrom as provided by law; Now, Therefore, I, R. A. Stitt Treasurer of the County aforesaid, for and in consideration of the said sum to the Treasurer paid as aforesaid, and by virtue of the Statute in such case made and provided, have granted, bargained and sold, and by these presents do grant, bargain and sell, unto the said H. J. B. Cummings his heirs and assigns, the real property last herein before described, to have and to hold unto him the said H. J. B. Cummings his heirs and assigns forever; subject however to all the rights of redemption provided by law. In witness whereof I, R. A.
