dollars, in hand paid by John Mullen of Madison County, State of Iowa the Grantee, do Give, Grant, Bargain, Sell and Convey unto the said Grantee his heirs and assigns, the following described premises, situated in the State of Iowa, County of Madison and described as follows, to wit; Lots number five & six (5 & 6) in the South West Section in the Town of St. Charles in said County & State. Lot No. 5 was conveyed to said Peter Richards by W^m Porter & wife by deed dated Feby. 25th 1864. & lot No 6 was conveyed to said Peter Richards by Mary J. Young Executrix of Jesse C. Young decd. by deed dated June 16. 1864. To have and to hold, the above granted and bargained premises with the appurtenances thereto belonging unto the said Grantee, his heirs and assigns forever. And we Peter Richards & Rebecca Richards do for ourselves and heirs, covenant with the said Grantee, his heirs and assigns, that at and until the insealing of these presents, we were well seized of the premises as a good and indefeasible estate in fee simple, and have good right to bargain and sell the same in manner and form as above written, and that the same are free from all encumbrances whatsoever; and will warrant and defend said premises, with the appurtenances, to the said Grantee, his heirs and assigns forever against all lawful claims and demands of all persons whomsoever, and Rebecca Richards wife of said Peter Richards do hereby Remise, Release and forever Quit Claim unto the said Grantee, and his heirs, all of my right and title of dower, in the above described premises, In Witness whereof, we have hereunto set our hands and seals the sixth day of February in the year of Our Lord, one thousand eight hundred and sixty five
