 of Iowa by the Clerk of said Court, tested the 9th
 day of May AD 1864 to me directed and delivered in a certain cause
 wherein B. B. Blakeslee is Plaintiff and E. R. Guiberson & Catherine
 Guiberson are Defendants, against the goods and chattels lands and
 tenements of the said E. R. Guiberson & Catherine Guiberson for want of
 sufficient personal property wherewithal to satisfy the amount and
 costs I did seize and levy upon on the 9th day of May AD 1864 on
 all the estate, right title and interest which the said E. R. Guiberson
 and Catherine Guiberson had on the 4th day of September AD 1858
 or at any time afterwards or now have in and to the following described
 property to wit: The undivided one half (½) of the North West Quarter

8 1/4 of Section No One (1) Township No Seventy four (74) North of Range No Twenty seven (27) West of the 5th P.M. Iowa. And after having advertised the said property for sale for four weeks immediately preceding the day of sale hereinafter mentioned in the Hawkeye Flag newspaper published in the city of Winterset Iowa and by notices of the same posted in three public places in said County of Madison one of which places being in the same Township in which said property is situated and one being on the front door of the Court House in said City of Winterset the place where the last District Court of said Madison County was held as required by law did on the 3rd day of June AD 1864 between the hours of 9 o'clock in the forenoon and 4 o'clock in the afternoon of that day proceed to sell the said property, after having first exposed the same for sale at public auction at the front door of the Court House aforesaid in Madison County Iowa and did then and there strike off the said property to T. J. Rhyno for the sum of Two Hundred Dollars. the said T. J. Rhyno being the highest bidder and Two Hundred Dollars being the highest and best sum bid therefor. And I certify that said sale was in all things fairly and honestly conducted without any fraud or deceit whatever. Now therefore know ye that I, H. C. Carter the Sheriff of the County of Madison State of Iowa by virtue of the said writ of special execution and of the statutes in such case made and provided in consideration of the said sum of Two Hundred Dollars (\$200) to me in hand paid by the said T. J. Rhyno the receipt whereof is hereby acknowledged have granted, bargained, sold and conveyed, and by these presents do grant, bargain sell and convey unto the said T. J. Rhyno his heirs and assigns forever, all of the estate, right, title and interest, which the said E. R. Giberson & Catherine Giberson had on the 4th day of September A.D. 1858 or at any time afterwards or now have in and to all the above mentioned property, to have and to hold the said property and every part thereof, unto the said T. J. Rhyno his heirs and assigns forever as fully and absolutely as the said H. C. Carter Sheriff aforesaid and under the authority aforesaid might, could or ought to sell and convey the same.
