





Know all Men by these presents, that we Peter Donaldson and Amanda Donaldson husband and wife, of the State of Missouri and County of Pike for and in consideration of the sum of Six Hundred and Fifty Dollars (\$650.00) to us in hand paid by Elias Worrell of the State and County aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained and sold and by these presents do grant, bargain, sell and convey unto the said Elias Worrell his heirs and assigns forever, the following described tract or parcel of land, lying and being in the State of Iowa, and County of Madison, to-wit; The North West quarter of Section Number Twenty (20) in Township number Seventy six (76) North of the Base line, of Range number Twenty nine (29) West of the Fifth Principal Meridian in the District of Lands subject to sale at Fort Des Moines, Containing One hundred and Sixty (160) acres more or less according to the United States Survey.
 To have and to hold together with all and singular, the rights, privileges immunities, improvements and appurtenances therunto belonging or in any wise appertaining unto him the said Elias Worrell his heirs and assigns forever, And we for ourselves our heirs, executors and administrators do hereby covenant with the said Elias Worrell his heirs and assigns that we will warrant and defend the title of Land and Premises hereby conveyed to the said Elias Worrell his heirs and assigns against the lawful claims and demands of all persons whomsoever.
