Know all Men by these presents, that we Peter Donaldson and Amanda Donaldson husband and wife of the State of Missouri and County of Pike for and in consideration of the sum of Four hundred Dollars (\$400.00) to us in hand paid by Hiram Worrell of the County and State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained and sold, and by these presents do grant, bargain sell and convey unto the said Hiram Worrell his heirs and assigns forever, the following described tract or parcel of land, lying and being the State of Iowa and County of Madison, to-wit; The South West quarter of Section Number Seventeen (17) in Township number Seventy six (76) North of the Base line, of Range number Twenty nine (29) West of the Fifth Principal Meridian, in the District of lands subject to sale at Fort Des Moines, containing One hundred and Sixty (160) Acres more or less according to the United States Survey. To have and to hold the same together with all and singular the rights, privileges, immunities, improvements and appurtenances therunto belonging or in any wise appertaining unto him the said Hiram Worrell his heirs and assigns forever; And we for ourselves our heirs Executors and Administrators do hereby covenant with the said Hiram Worrell his heirs and assigns, that we will warrant the title of land hereby conveyed to the said Hiram Worrell his heirs and assigns, against the lawful claims and demands of all persons whomsoever.
