of Madison County, State of Iowa, in consideration of the sum of Nine hundred and Seventy five dollars, in hand paid, do hereby sell and convey, unto G. M. Rutledge of Madison County, and State of Iowa, the following described premises, to-wit; The South East Fourth ( $\frac{1}{4}$ ) of the South West Fourth ( $\frac{1}{4}$ ), and Twenty five Acres off of the West side of the South West fourth ( $\frac{1}{4}$ ) of the South East Fourth, And Eight Acres off of the West end of the North half of the South East fourth of the North West fourth of Section Thirty (30) Township Seventy six (76) North Range Twenty eight (28) West, and also Five acres of the Undivided South West fourth ( $\frac{1}{4}$ ) of the North West fourth ( $\frac{1}{4}$ ) of Section Fourteen (14) Township Seventy five (75) North Range Twenty eight (28) + all of 5<sup>th</sup> P. M. Iowa, and we do hereby covenant with the said G. M. Rutledge that we are lawfully seized, in fee simple, of said premises, that they are free from Incumbrance, that we have good right and lawful authority to sell the same, and we do hereby covenant to warrant and defend the said premises, and appurtenances thereto belonging, against the lawful claims of all persons whomsoever; and the said Mary Jane Swafford & Emily Wilson hereby relinquishes all their right of dower in and to the above described premises, Signed the 8<sup>th</sup> day of December A.D 1863


