Know all Men by these presents, that we
Samuel M. Greger and Rebecca Jane Greger,
of the County of Madison and State of Iowa,
in consideration of the sum of One hundred &
fifty five dollars, in hand paid, by Hogan Queen of Madison County
and State of Iowa do hereby sell and convey unto the said Hogan Queen
the following described premises, situated in the County of Madison and State
of Iowa, to-wit; The Undivided One fifth ($\frac{1}{5}$) part of the North East $\frac{1}{4}$ of the
South West $\frac{1}{4}$ of Section (20) Twenty (excepting 5 acres off of the North East corner)
Township No (75) Seventy five Range No (26) Twenty six, And the South West $\frac{1}{4}$
of the South West $\frac{1}{4}$ of Section No (25) Twenty five. And the South East $\frac{1}{4}$ of
the South East $\frac{1}{4}$ of Section No (26) Twenty six Township No (75) Seventy five
Range No (27) Twenty seven, subject to Dower of Widow therein.
And we hereby covenant with the said Hogan Queen that we hold said premises
by good and perfect title; that we have good right and lawful authority to sell and
convey the same; that they are free and clear of all liens and incumbrances whatsoever.
And we covenant to warrant and defend the said premises against the lawful claims of all
persons whomsoever. And the said Samuel M. Greger hereby relinquishes his right of dower in
