Know all Men by these Presents, That William Ogden & Maria Ogden his wife of Madison County and State of Iowa in consideration of the sum of One Thousand ¹⁰⁰ Dollars, in hand paid, by Jacob Troutth of Madison County, and State of Iowa do hereby **Sell and Convey**, unto the said Jacob Troutth

the following described premises, situate in the County of Madison, and State of Iowa, to-wit: West half $\frac{1}{2}$ of South West quarter $\frac{1}{4}$, and North West quarter $\frac{1}{4}$ of South East quarter $\frac{1}{4}$ of Section number Thirty three (33) & South West quarter $\frac{1}{4}$ of North West quarter $\frac{1}{4}$, and North East quarter $\frac{1}{4}$ of North West quarter $\frac{1}{4}$, and North East quarter $\frac{1}{4}$ of South West quarter $\frac{1}{4}$, all in Section number Thirty three (33) Township number Seventy six (76) North of Range number Twenty six (26) West of the 5th P.M. Iowa. Containing Two Hundred and forty Acres more or less.

And We hereby covenant with the said Jacob Troutth

that We hold said premises by good and perfect title, that We have good, right, and lawful authority, to sell and convey the same: that they are free, and clear of all liens and incumbrances whatsoever. And We covenant to warrant and defend the said premises against the lawful claims of all persons whomsoever; and the said Maria Ogden hereby relinquishes her right of dower in and to the above described premises.
