Know all Men by these Presents, That we Jacob Kimerer and Stanzy Kimerer his wife of Madison County and State of Iowa in consideration of the sum of Five Hundred ¹⁰⁰ Dollars, in hand paid, by Joseph M. Kimerer of Madison County, and State of Iowa do hereby **Sell and Convey**, unto the said Joseph M. Kimerer

the following described premises, situate in the County of Madison, and State of Iowa, to-wit:

The West (1/2) half of the South East quarter of the South East quarter section, of section No (16) Sixteen Township (75) Seventy five North of Range (26) Twenty six West containing Twenty acres more or less. And (10) Ten Acres off of the North East (1/4) quarter of the South East quarter of section No (16) Sixteen Township (75) Seventy five North of Range (26) Twenty six West, Containing (10) Ten acres more or less. And the North West (1/4) quarter of the North East quarter (except (10) Ten Acres off of the North side of said forty acres) of Section No (21) Twenty one Township (75) Seventy five North of Range (26) Twenty six West, Containing (30) Thirty Acres more or less.

And we hereby covenant with the said Joseph M. Kimerer that we hold said premises by good and perfect title, that we have good, right, and lawful authority, to sell and convey the same: that they are free, and clear of all liens and incumbrances whatsoever. And we covenant to warrant and defend the said premises against the lawful claims of all persons whomsoever; and the said Stanzy Kimerer hereby relinquishes her right of dower in and to the above described premises.
