This Indenture, made this 28th
day of January in the year of our
Lord One Thousand Eight Hundred
and Sixty-five, between Zadok

Montgomery, and Sarah Jane Montgomery, his wife, of the first part,
and William Raup of the second part. It witnesseth, that the
said party of the first part in consideration of the sum of Four
Hundred Dollars, in hand paid, the receipt whereof is hereby ack-
nowledged, has granted, bargained, and sold, and by these presents
do grant, bargain, and sell unto the said party of the second
part, his heirs and assigns, all that piece or parcel of land situate
in the County of Madison, and State of Iowa, to wit: The north
fractional half of the North East quarter of Section Two, in Township
Seventy-four, North of Range twenty-nine, West in the district of
lands subject to sale at Chariton, State of Iowa, containing Seven-
ty-seven acres, and thirty-four hundredths.

Together with the appurtenances thereto belonging; and all
the estate, right, title, interest claim and demand of the said party of
the first part herein named. And the said Zadok Montgomery, and
Sarah Jane Montgomery, his wife, for their heirs, executors and admin-
istrators, do covenant, grant, bargain, and agree to and with the
said party of the second part his heirs and assigns, that the above
bargained premises in the quiet and peaceable possession of the said
party of the second part, his heirs and assigns, the said party of
the first part shall and will warrant and forever defend,
