No 3 Administrator's Deed.
Hamilton Tee.

We now all men by these presents, that
whereas John W. Earp, of the County
of Putnam in the State of Indiana
was by the County Court of Madison

County, Iowa, on the 25th day of August, A.D. 1864, was duly constituted
and appointed the legal Administrator of John F. Finley, late of Putnam
County, State of Indiana, and was by the said County Court, sitting
as a court of probate within and for said County of Madison in the
State of Iowa, on the 3rd day of October, 1864, authorized as said
Administrator, and empowered by order of said Court to sell at not
less than One Hundred Dollars, the following described Real Estate, to wit
East half ($\frac{1}{2}$) of Lot No. Seven (7) in Block No. Sixteen (16) in Original
Town plat of the City of Winterset, Madison County, Iowa, all of
which will more fully appear reference being had to the records of the
said Court. Therefore I, the said John W. Earp, as Administrator as
aforesaid of a sale duly made this day to Hamilton Tee, of Madison
County in the State of Iowa, of the said East half ($\frac{1}{2}$) of Lot No. Seven (7) in
Block No. Sixteen (16) in the Original Town Plat of Winterset, Iowa, do in
consideration of the sum of One Hundred Dollars in hand paid by the said
purchaser the receipt whereof is hereby acknowledged, and of the order above
referred to, to sell, convey, deed and pass unto the said Hamilton Tee,
the said last described Real Estate, to have and to hold the same with all
the privileges and improvements and appurtenances thereto belonging or in
any wise appertaining, unto the said Hamilton Tee his heirs and assigns
