This Indenture, made the first day of February in the year of our Lord One thousand Eight hundred and Sixty five, between Almer Bradbury and Sarah his wife of the first part, and B. B. Bradbury all of Washington County and State of Pennsylvania, of the second part, Witnesseth, that the said party of the first part, for and in consideration of the sum of Eight hundred and fifty Dollars lawful money of the United States of America, unto — well and truly paid by the said part of the second part, at or before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, granted, bargained, sold, aliened, enfeoffed, released, conveyed and confirmed, and by these presents grant, bargain, sell, alien, enfeoff, release, convey and confirm unto the said part of the second part ~~heirs~~ and assigns, all of certain parcels of land situated and being in Madison County and State of Iowa, described as follows, North West quarter of South East quarter of Section Thirty four Township Seventy seven North of Range Twenty eight west, and the East half of the South East quarter, and the South East quarter of the North East quarter of Section Twenty seven Township Seventy seven North; of Range Twenty eight West, containing One hundred and Sixty Acres according to Government survey, Together with all and singular the improvements, ways, waters, water-courses, rights liberties, privileges, hereditaments and appurtenances whatsoever thereunto belonging or in any wise appertaining, and the reversions and remainders, rents, issues, and profits thereof; and all the estate, right, title, interest, property, claim and demand whatsoever of the said parties of the first part, in law, equity or otherwise howsoever, of, in and to the same and every part thereof, To have and to hold the said pieces of land their hereditaments and premises hereby granted, or mentioned, and intended so to be, with the appurtenances, unto the said party of the second part, his heirs and assigns, to and for the only proper use and behoof of the said party of the second part, his heirs and assigns forever. And Almer Bradbury and Sarah his wife the said parties of the first part, their heirs, executors and administrators, do by these presents covenant, grant and agree to and with the said party of the second part, his heirs and assigns, that they the said parties of the first part, their heirs, all and singular the hereditaments and premises, herein above described and granted, or mentioned, and intended so to be, with the appurtenances, unto the said party of the second part, his heirs and assigns, against all the said parties of the first part, and their heirs, and against all and every other person or persons whomsoever lawfully claiming or to claim the same or any part thereof, shall and will warrant and forever defend. In witness whereof, the said parties of the first part have to these presents set their hands and seals, Dated the day and year first above written.


