Arnold ~~of~~ ~~Madison~~ County, and State of Iowa do hereby **Sell and Convey**, unto the said Samuel B. Arnold ~~and~~ ~~the following described premises, situate in the County of Madison, and State of Iowa, to-wit:~~

Twenty acres out of the North East quarter of Section No "16" Sixteen Township No "76" Seventy six Range "28" Twenty eight described as follows, to wit; Beginning Forty "40" Rods East of the South West corner of said quarter section Running thence North Eighty "80" Rods thence East forty "40" Rods thence South Eighty "80" Rods thence West forty "40" Rods to the place of beginning ~~and so forth~~

And We hereby covenant with the said Samuel B.
