Cordell his heirs and assigns forever, the following Real Estate to-wit; The South East quarter of Section Thirty three "33" Township "75" North, Range Twenty nine "29" West, containing by Government survey One hundred and Sixty "160" Acres more or less, laying in Madison County State of Iowa, and all the Estate, title and interest of the said George W. Cordell either in law or in equity, of, in and to the said premises, Together with all the privileges and appurtenances to the same belonging; To have and to hold the same to the only proper use of the said Mo. W. Cordell his heirs and assigns forever. And the said George W. Cordell for himself, heirs, executors and administrators hereby covenant with the said Mo. W. Cordell his heirs and assigns, that he is the true and lawful owner of the said premises, and have full power to convey the same, and that the title so conveyed is clear, free, and unincumbered; and further, that — will warrant and defend the same against all claim or claims of all persons whatsoever.
