Moser of Madison County Iowa, Trustees in trust, for the use hereinafter mentioned, all of State and Counties above named, of the other part, Witnesseth that the said J. M. Browne & Mary his wife have granted, bargained, sold, and released, confirmed and conveyed, for the sum of Three hundred dollars in hand paid, at and upon the selling and delivery of these presents, the receipt whereof is hereby acknowledged, hath granted, bargained, sold, released, confirmed and conveyed and by these presents doth grant, bargain and sell, confirm and convey, unto them the said Trustees and their successors, in trust for the use hereinafter mentioned and declared all the Estate, right, title, interest, Property, claim and demand, whatsoever in Law or Equity which they have in, to, or upon all and singular, certain Two Lots in the Town of St. Charles Madison Co. Iowa, described as follows; viz: Lots Three "3" & Six "6" in the South East Section of said Town, with the house thereon Erected, together with all and singular the Ways, Privileges, and Appurtenances thereunto belonging, or in any wise pertaining to, To have and to hold all and singular the above mentioned and described Lots together with all and singular the above named and described Lots together with all and singular, the ways, privileges thereto belonging or in any wise appertaining unto them the said Trustees, and their successors in Office forever in Trust, as a House of worship for the use of the Members of the "Methodist Episcopal Church in the" United States of America, according to the Rules and Discipline which from time to time may be agreed upon and adopted, by the Ministers and Preachers of said Church at their "General Conference" in the United States of America, and in further trust and confidence, that they shall

at all times forever hereafter permit such Ministers and preachers belonging to said Church, as shall from time to time be duly authorized by the general Conferences of the Ministers and Preachers of the said "Methodist Episcopal Church" or by the Annual Conferences authorized by the said "General Conference" to Preach and Expound, Gods Holy Word therein. And the said J. M. Browne & Mary his wife doth by these presents warrant and forever defend, all and singular the before mentioned and described lots, with appurtenances thereto belonging, unto them the said Trustees and their successors in Office, chosen and appointed as aforesaid, from the claim or claims of them the said J. M. Browne & Mary his wife their heirs and assigns, and from the claim or claims of all persons whatever. In testimony whereof the said J. M.
