This deed made and entered into this
seventeenth day of June A.D. 1865, by and
between James D. Whitney and Sophia his
wife of Sandusky City Erie County Ohio, Jonathan D. Whitney of the State of
Iowa, Henry L. Whitney of the City and County of St. Louis in the State of
Missouri, Francis Whitney of St. Louis County Missouri, Margaret D. Whitney
of Springfield Hampden County Massachusetts, parties of the first part,
and all heirs of Robert S. Whitney deceased, and Margaret A. Whitney of
Springfield Hampden County Massachusetts, party of the second part, witnesseth,
That said parties of the first part in consideration of the love and affection
which they have for their Mother, the said Margaret A. Whitney and for the
further consideration of One dollar to them in hand paid by the said Margaret
A. Whitney have remised, released and forever quit claimed and do by these presents
remise, release, and forever quit claim unto the said party of the second part, all
their right, title, interest and claim, in and to all lands, lots, real estate and
property which belong to the Estate of Robert S. Whitney deceased, late of St. Louis
Missouri, wherever the same may be situated, the lands, lots and Real Estate,
belonging to the Estate of said Robert S. Whitney deceased, being described more
particularly as follows; to-wit; The South West quarter of the North West quar-
ter of Section Fourteen, and the East half of the North East quarter of Section
Fifteen, in Township Twenty seven of Range Thirty three in the district of
lands subject to sale at Springfield Missouri, containing One hundred and
twenty acres, And also the following described piece of ground; The East
half of the North West quarter, and the North West quarter of the North West
quarter of Section Fourteen, in Township Twenty seven of Range Thirty three
in the district of lands subject to sale at Springfield Missouri, Containing
One hundred and twenty acres; and also the following described lands; lying
and being in the County of Washington and State of Missouri, to-wit; The
East half of Section Eleven, and the South East quarter of Section Two, and
Lot number One of the North East quarter of Section Two, all being in Town-
ship number Thirty seven North, Range One West of the Fifth Principal
Meridian; and also the following described lands lying and being in the
County of Madison and State of Missouri, to-wit; Lots numbers One "1"

taining One hundred and Seventy eight Acres and sixteen hundredths "178 $\frac{16}{100}$ "
of one acre, more or less, Also the North half of lot number One "1" of the South

Five "5" East of the fifth Principal Meridian, and containing Forty "40" acres
more or less; also the following described lands, to wit; The East half of the
