All of said land in Madison County Iowa, together with the privileges and appurtenances to the same belonging. To have and to hold the same to the said Henry Buckmaster his heirs and assigns forever.

We hereby covenanting that the title so conveyed is clear, free and unencumbered, and that we will warrant and defend the same against all claims whatsoever.
