This Deed of Bargain and Sale, Made
and Executed this 23rd day of February
A D 1865, by and between John Seach and Margaret Seach of
the County of Madison and State of Iowa, party of the first part,
and William Garrett of the second part, Witnesseth, That the
said party of the first part, for and in consideration of the sum
of One hundred and Ninety five dollars, to them paid by the
said party of the second part, the receipt of which is hereby acknow-
ledged, have granted and sold, and do by these presents,
Grant, Bargain, Sell, Convey and Confirm unto the said party
of the second part, his heirs and assigns forever, the certain
tract or parcel of Real Estate in the County of Madison State
of Iowa, to-wit; Five Acres out of the North West quarter of the
South East quarter of Section No Eleven (11), described as follows
to wit; Beginning at the South East corner of said North West
 $\frac{1}{4}$ of the South East ($\frac{1}{4}$) of said Section; running thence West Twenty
(20) rods, thence North forty (40) rods, thence East twenty (20) rods,
thence South forty (40) rods to the place of beginning.
Also Seven (7) acres out of the South West quarter of the South East
quarter of Section No Eleven (11) commencing at the North West
corner of the South East quarter of said Section, Thence West Twenty
(20) rods, thence South Fifty six (56) rods, thence East twenty (20) rods,
thence North fifty six (56) rods to the place of beginning, all in Town-
ship No Seventy six (76) Range No Twenty eight (28)
To have and to hold, the premises above described, with all the appurte-
nances thereto belonging, unto him the said second party, and to
his heirs and assigns forever. The said John Seach and Margaret
Seach hereby covenanting for their heirs, executors and adminis-
trators, that the above described premises are free from any incum-
brance, that they have full right, power and authority to sell the
same, and they will warrant and defend the title unto the said party
of the second part, his heirs and assigns, against the claims of
all persons whomsoever, lawfully claiming the same. And the
said Margaret Seach wife of the said John Seach hereby releases
and relinquishes all her right of dower in and to the foregoing
described premises. In witness whereof, the said partys of the
