Two Hundred Dollars, in hand paid, by  
William H. Bard of Madison County, and State of  
Iowa do hereby **Sell and Convey**, unto the said  
William H. Bard

the following described premises, situate in the County of Madison, and State of Iowa, to-wit:  
Ten Acres out of the North East quarter of Section No (16) Sixteen Township No (76) Seventy six, Range No (28) Twenty Eight West, commencing at a point (40) Forty rods North of the South East corner of said quarter section, running thence West (40) Forty rods, thence North (40) forty rods, thence East (40) forty rods, thence South (40) forty rods to the place of beginning

And We hereby covenant with the said William H. Bard that We hold said premises by good and perfect title, that We have good, right, and lawful authority, to sell and convey the same: that they are free, and clear of all liens and incumbrances whatsoever. And We covenant to warrant and defend the said premises against the lawful claims of all persons whomsoever; and the said Elizabeth Cassatt hereby relinquishes her right of dower in and to the above described premises.
