Know all Men by these Presents, That we John Leonard and
 Minerva D. Leonard wife of the said John Leonard
 of Madison County and State of Iowa in consideration of the sum of
 Seven hundred and fifty ¹⁰⁰ Dollars, in hand paid, by
 Mary E. Elliott of Madison County, and State of
 Iowa do hereby **Sell and Convey**, unto the said Mary E. Elliott

the following described premises, situate in the County of Madison, and State of Iowa, to-wit:
 All of that part of the North East quarter (1/4) of the South West quarter (1/4)
 of Section number Thirty Six (36) in Township number Seventy six
 North; of Range number Twenty eight (28) West of 5th P. M. which
 lies North of a line extending Westward from and on the same
 course with the centre of Jefferson Street in the City of Winterset,
 the said line being now the centre of the State Road leading from
 Winterset to Lewis via Fontanelle, except Five (5) acres in the
 North East corner of the same, the premises herein and hereby
 conveyed, containing Seventeen (17) acres.

And we hereby covenant with the said Mary E. Elliott
