This indenture made this eleventh day of September in the year of our Lord one thousand eight hundred and Sixty five between Margaret Rodgers and Mary E Rodgers of the first part and Isaac Stevens of the second Witnesseth that the said parties of the first part for and in consideration of the sum of Twelve Hundred Dollars paid by the said party of the second part the receipt of which is hereby acknowledged have granted bargained sold conveyed and confirmed and by these presents do grant bargain sell and confirm unto the said party of the second part his heirs and assigns a certain tract or parcel of land situated in the county of Madison and State of Iowa and described as follows viz The East half of the South west quarter and the East half of the North West quarter of section thirty three (33) in Township Seventy four North of Range twenty eight (28) West of the fifth principal meridian being One hundred and sixty acres Together with all the singular the hereditaments privileges and appurtenances thereto belonging or in any wise appertaining To have and to hold the said premises as above described with the appurtenances to the said party of the second part his heirs and assigns forever And the said parties of the first Part for themselves and their heirs executors and administrators do hereby covenant to and with the said party of the second part his heirs executors administrators & assigns that they are well seized of the premises above conveyed as of a good and indefeasible estate in fee simple and have good right to sell and convey the same in manner and form as aforesaid that they are free from all encumbrance and that the above bargained premises in the quiet and peaceable possession of the said party of the second part his heirs or assigns against the claim of all persons whomsoever will warrant and forever defend I witness whereof The said parties of the first part have here unto set their hands and seals The day and year first above written
