 tofore to wit at the October session A.D 1865 of the County Court  
 of Marion County and State of Iowa made application to the said  
 Court to sell The North west quarter of the North west quarter &  
 North half of South west quarter of North west quarter of Section 25  
 & North East quarter of the North East quarter & North half of the  
 South East quarter of the North East quarter of Section 26 & East  
 half of the South East quarter of section 23 Township 75 North of Range  
 27 west in Madison County Iowa and Whereas notice of said  
 application was duly and personally served upon Said minor accor-  
 ding to law and whereas also at the said November Term A.D 1865  
 of said County Court the said William A Egenbright in his  
 capacity of Guardian aforesaid was ordered and empowered to sell  
 the above described Real Estate and whereas also the said Guardian has  
 given the bond with Sureties required by law and whereas also  
 the said Guardian has sold the Real Estate herein after described being

tract of Real Estate lying and being situated in the County of Madison and State of Iowa to wit The undivided four fifths of the North west quarter of the North west quarter & the North half of the South west of the North west of section 25 & the North East quarter of the North East quarter & the North half of the South East quarter of the North East quarter of section 26 and the East half of the South East quarter of section 28 Township 75 North of range 27 west To have and to hold The said described premises unto the said Noah M King his heirs and assigns forever and I the said William A Egenbright for myself my executors and administrators do hereby covenant with the said Noah M King his heirs and assigns that in making the said sale I have in all things observed and complied with all the requisitions of the law and that as Guardian aforesaid I will warrant and defend the above granted premises to the said Noah M King against the lawful claims of said minor and all persons claiming or to claim the same by through or under them In testimony whereof I have hereunto set my hand and seal this the 10th day of November AD 1865
