said party of the second part and to his heirs and assigns forever  
The North half of the North west fractional quarter of Section  
Nineteen in Township Seventy five Range twenty six west also  
the North East quarter of the North East quarter of Section  
Twenty <sup>one</sup>, and in said Township and Range twenty seven  
west also the North west quarter of the South west quarter  
of Section twenty two in said Township and Range twenty seven  
west containing in all One hundred and Eleven acres more

or less in the county of Madison and State of Iowa  
 Together with all and singular the hereditaments  
 and appurtenances there unto belonging or in any  
 wise appertaining To have and to hold the said premises  
 as above described to the said party of the second part  
 and to his heirs and assigns to the sole and only proper use  
 benefit and behoof of the said party of the second part  
 his heirs and assigns forever in witness whereof
