State of Iowa Guardian of the property of Winfield S Kelly minor heir of Alfred Kelly sends greeting whereas the said R A Stitt Guardian as aforesaid heretofore to wait at the November session AD 1865 of the county court of Madison County and State of Iowa made application to the said court to sell certain herein after described Real estate and whereas notice of said application was duly and personally served upon said minor according to law and whereas also at the said November term AD 1865 of said County Court the said R A Stitt in his capacity of Guardian aforesaid was ordered and empowered to sell said Real Estate And whereas also The said Guardian has given the Bond with sureties required by law And whereas also The said Guardian has sold the Real Estate herein after described being all of the said Real Estate which the said Guardian was empowered to sell by said order of said County Court to Chas A Gaskill of Madison County in the State of Iowa for the sum of Two Hundred Dollars Now therefore know ye That I the said R A Stitt in my capacity of Guardian as aforesaid by virtue of the authority vested in me by said County Court and in pursuance of the said order of said Court in consideration of the said sum of Two Hundred Dollars to me paid by the said Chas A Gaskill the receipt whereof I hereby acknowledge do by these presents grant bargain sell and convey unto the said Charles A Gaskill and to his heirs and assigns forever the following described tracts of Real Estate lying and being situated in the County of Madison and State of Iowa to wit The undivided one third part of lot number six 6 in Block number Ten (10) original plat of the City of Winterset To have and to hold the said described premises unto the said Chas A Gaskill his heirs and assigns forever And I the said R A Stitt for myself my executors and administrators do hereby covenant with the said Chas A Gaskill his heirs and assigns that in making the said sale I have in all things observed and complied with all the requisitions of the law and that as Guardian as aforesaid I will warrant and
