Know all men by these  
presents That whereas the

following described real prop-  
erty viz North West quarter of North East quarter of  
Section No Twenty seven (27) Township seventy seven (77)  
N of Range No Twenty six (26) W situated in the  
county of Madison and state of Iowa was subject  
to taxation for the year AD 1860 & 1861 and whereas  
the taxes assessed upon said real property for the  
year aforesaid remained due and unpaid at the  
date of the sale herein after named and whereas the Treasurer  
of the said county did on the 3<sup>rd</sup> day of November 1865  
by virtue of the authority in him vested by law at  
the tax sale begun and publicly held on the first  
Monday of November AD 1862 expose to public sale at the  
Treasurers Office in the county aforesaid in sub-  
stantial conformity with all the regulations of the  
statute in such case made and provided the real  
property above described for the payment of the taxes  
interest and costs then due and remaining unpaid  
on said property and whereas at the time and place  
aforesaid B G Allen of the county of Polk and state  
of Iowa having offered to pay the sum of Five Dollars  
Ninety Nine cents being the whole amount of taxes in-  
terest and costs then due and remaining unpaid on  
said property for NW $\frac{1}{4}$  of NE $\frac{1}{4}$  of section twenty seven  
(27) Township No Seventy seven (77) N of Range No Twenty six (26)  
W which was the least quantity bid for and payment  
of said sum having been by him made to the said  
Treasurer the said property was stricken off to him at  
that price And whereas B G Allen has assigned his  
certificate of purchase to S V White and whereas  
three years has elapsed since the date of said sale and  
the said property has not been redeemed therefrom as  
provided for by law Now therefore I R A Stitt Treasurer  
of the county aforesaid for and in consideration of the  
said sum to the Treasurer paid as aforesaid and by  
virtue of the statute in such case made and provided  
have granted bargained and sold and by these presents  
do grant bargain and sell unto the said S V White  
his heirs and assigns the real property last hereinbefore  
described To have and to hold unto him the said  
S V White his heirs and assigns subject however  
to all the rights of redemption provided by law
