Know all men by these presents That whereas the following described real property viz. South East quarter of North west quarter of section No Twenty nine (28) Township No Seventy seven (77) N of Range Twenty six (26) W of 5th P M situated in the County of Madison and state of Iowa was subject to taxation for the year A D 1858 1860 & 1861 and whereas the taxes assessed upon said real property for the year aforesaid remained due and unpaid at the date of the sale hereinafter named and whereas the treasurer of the said county did on the 3rd day of November 1862 by virtue of the authority in him vested by law at the tax sale began and publicly held on the first Monday of November A D 1862 expose to public sale at the Treasurers office in the county aforesaid in substantial conformity with all the requisitions of the statute in such case made and provided the real property above described for the payment of the taxes interest and costs then due and remaining unpaid on said property and whereas at the time and place aforesaid B F Allen of the county of Polk and state of Iowa having offered to pay the sum of Seven Dollars Seventy cents being the whole amount of taxes interest and costs then due and remaining unpaid on said property for the South East qr of North West qr of section No Gen²⁹ (70) Township No Seventy seven (77) N of Range Twenty six (26) W which was the least quantity bid for and payment of said sum having been by him made to the said treasurer the said property was stricken off to him at that price And whereas B F Allen has assigned his certificate of purchase to S V White and whereas three years has elapsed since the date of said sale and the said property has not been redeemed therefrom as provided for by law Now therefore I R A Stitt
