Robert Neal Know all men by these presents; That we
Thomas D. Jones and Rebecca Ann Jones of
 Madison County and State of Iowa, for and in consideration
 of the sum of One thousand dollars in hand paid by Robert Neal
 of Madison County and State of Iowa, do hereby sell and convey
 unto the said Robert Neal the following described premises, sit-
 uated in the County of Madison and State of Iowa, to-wit;
 Beginning at the half mile corner of the North West quarter of
 the South West quarter of Section Five, in Township Seventy six
 North; of Range Twenty six West, Running thence East to North
 River, thence down said River to the East line of said forty,
 thence South to the South East corner, thence to the South West
 corner, thence North to the place of beginning, Containing Thirty
 Seven Acres.— Also, Beginning at the North West corner of the
 South West quarter of the South East quarter of Section Seven
 in Township Seventy six North; of Range Twenty six West.
 Running thence South with the half mile line to South Elm creek,
 thence down said Creek to North Elm Creek, thence down said
 creek to Cedar Creek, thence down said Cedar Creek to the East
 line of the North West quarter of the North East quarter of Section
 Eighteen in Township and Range aforesaid thence North to the
 North East corner of last mentioned forty, thence West with the
 Section line Twenty rods, thence North Eighty rods, thence West
 sixty rods to the half mile line, to the place of beginning, contain-
 ing Sixty six acres.— Also beginning twelve rods South of the Centre
 of the North line of the North West quarter of the South West quarter of
 Section Thirty six, Township Seventy six North; of Range Twenty
 seven West of the fifth Principal Meridian of Iowa, running thence
 South Twenty eight rods, thence West twenty rods, thence North twenty eight
 rods, thence East twenty rods to the place of beginning containing three and
 a half acres. And we do hereby covenant with the said Robert Neal that we hold
 said premises by good and perfect title, that we have good right and lawful
 authority to sell and convey the same, that they are free and clear of all incumbrances
 and we warrant and defend said premises against the lawful claims of all persons
