Know all men by these presents that whereas the following described real property viz. $\frac{1}{4}$ of NE $\frac{1}{4}$ & NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of section three (3) & SE $\frac{1}{4}$ NW $\frac{1}{4}$ of section fifteen (15) & the W $\frac{1}{4}$ of NE $\frac{1}{4}$ & E $\frac{1}{4}$ of NW $\frac{1}{4}$ & SW $\frac{1}{4}$ & W $\frac{1}{4}$ of SE $\frac{1}{4}$ of section no Twenty two (22) & E $\frac{1}{4}$ of NW $\frac{1}{4}$ & SW $\frac{1}{4}$ & Thirty acres off the south part of the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of section no Twenty seven (27) all in Township seventy seven 77 N of Range Twenty six (26) W situated in the county of Madison and state of Iowa was subject to taxation for the year A D 1861 and whereas the taxes assessed upon said real property for the year aforesaid remained due and unpaid at the date of the sale hereinafter named and whereas the treasurer of said county did on the 3rd day of November 1862 by virtue of the authority in him vested by law at the tax sale begun and publicly held on the first Monday of November A D 1862 expose to public sale at the Treasurers office in the county aforesaid in substantial conformity with all the requisitions of the statute in such case made and provided the real property above described for the payment of the taxes interest and costs then due and remaining unpaid on said property and whereas at the time and place aforesaid B D Allen of the county of Polk and state of Iowa having offered to pay the sum of seventy two (72) Dollars & twenty (20) Cents being the whole amount of taxes interest and costs then due and re-

maining unpaid on said property for all of the above described land which was the least quantity bid for and payment of said sum having been by him made to the said treasurer the said property was stricken off to him at that price and whereas B G Allen has assigned his certificate of purchase to S V White and whereas three years has elapsed since the date of said sale and the said property has not been redeemed therefrom as provided by law Now therefore I R A Stitt Treasurer of the county aforesaid for and in consideration of the said sum to the treasurer paid as aforesaid and by virtue of the statute in such case made and provided have granted bargained and sold and by these presents do grant bargain and sell unto the said S V White his heirs and assigns the real property last herein before described to have and to hold unto him the said S V White his heirs and assigns forever subject however to all the rights of redemption provided by law In witness whereof I R A Stitt Treasurer as aforesaid by virtue of the authority aforesaid have hereunto subscribed my name on this 6th day of November 1865
