**Know all Men by these Presents,** That We Sylvester Clifton and  
Mariah Clifton wife of said Sylvester Clifton are  
of Madison County and State of Iowa in consideration of the sum of  
Seven Hundred <sup>100</sup> Dollars, in hand paid, by  
Caleb Carver of Madison County, and State of  
Iowa do hereby **Sell and Convey**, unto the said  
Caleb Carver

the following described premises, situate in the County of Madison, and State of Iowa, to-wit:

The East fractional half ( $\frac{1}{2}$ ) of the North West quarter ( $\frac{1}{4}$ )  
of Section number Thirty (30) in Township number  
Seventy four (74) North; of Range number Twenty six (26)  
West, of  $5^{\text{th}}$  P.M., And also Ten (10) Acres off of the South side  
of the South East quarter ( $\frac{1}{4}$ ) of the South West quarter ( $\frac{1}{4}$ ) of  
Section number fifteen (15) in Township number Seventy  
four (74) North; of Range number Twenty seven (27)  
West of  $5^{\text{th}}$  P.M. Containing in all Eighty Seven and  
one tenth ( $87\frac{1}{10}$ ) Acres more or less.

and perfect title, that We have good, right, and lawful authority, to sell and convey the same: that  
they are free, and clear of all liens and incumbrances whatsoever. And We covenant to warrant

described premises.
