To all to whom these presents shall come,
I, Reuben A. Kale of Madison County,
State of Iowa, Guardian of the persons
and property of John C. Reed and

James A. Reed, Minor heirs William Reed late of Madison County
deca. seras greeting; Whereas the said Reuben A. Kale Guardian
as aforesaid, heretofore to-wit: at the February Session A.D 1865, of the
County Court of Madison and State of Iowa, made application
to the said Court, to sell the lands hereinafter described.
And whereas, Notice of said application was duly and personally
served upon said Minors, according to law; And Whereas, also,
at the said February term A.D 1865, of said County Court, the said
Reuben A. Kale in his capacity of Guardian aforesaid was
ordered and empowered to sell the same. And whereas also,
The said Guardian has given the bond with sureties required by
law. And whereas also, The said Guardian has sold the Real
Estate hereinafter described, (being all of the said Real Estate
which the said Guardian was empowered to sell by said Order
of said County Court,) to Hogan Queen, of Madison County, in
the State of Iowa, for the sum of Four hundred and forty eight
Dollars. Now, Therefore, Know ye, That I the said Reuben A. Kale
in my capacity of Guardian as aforesaid, by virtue of the authority
vested in me by said County Court, and in pursuance of the said
order of said Court, in consideration of the said sum of Four
hundred and forty eight dollars, to me paid by the said Hogan
Queen (the receipt whereof I hereby acknowledge,) do by these presents
grant, bargain, sell and convey unto the said Hogan Queen and
to his heirs and assigns, forever, the following described tracts of
Real Estate, lying and being situated in the County of Madison
and State of Iowa, to-wit: The North East quarter of the South
West quarter of Section No Twenty (20) Township (75) Seventy five

Range (26) Twenty six, excepting 5 acres out of the North East corner,
 And the South West quarter of the South West quarter of Section Twenty
 five (25), and the South East quarter of the South East quarter of Section
 No Twenty six (26) Township Seventy five (75) Range Twenty seven (27)
 West, Madison County Iowa, To have and to hold the said described
 premises unto the said Hogan Queen his heirs and assigns forever.
 And I the said Reuben A. Kale for myself, my executors and ad-
 ministrators do hereby covenant with the said Hogan Queen his
 heirs and assigns, that in making the said sale, I have in all things
 observed and complied with all the requisitions of the law, and that
 as Guardian as aforesaid, I will warrant and defend the above
 granted premises to the said Hogan Queen, against the claims
 of said Minors and all persons claiming or to claim the same by,
